The IT Manager will first and foremost ensure compliance of IT systems with financial (SOX, SEC) and regulatory (GxP, Data Integrity, FDA CFR Part 11) requirements, identify, recommend, and implement cost effective technology solutions for all aspects of the organization, and provide front-line service support to end-users.

### Key Responsibilities

- Oversee the company IT infrastructure in its Ottawa, ON and Cambridge, US offices (network hardware, end-user computing, telephony), ensuring the IT operations are appropriately maintained, secure and redundant
  - Identify, monitor, troubleshoot and resolve problems related to network, hardware, operating systems, software and telephony to ensure optimal operation.
  - Act as the administrator/super user for corporate application software including, but not limited to Quality Management System, Document Management System, ERP, Microsoft Suite and other internal applications.
  - Act as the first line of support to end-users, for the deployment, monitoring, maintenance, development, upgrade, and support of all current IT systems, including installation and configuration of new hardware operating systems, phones, software, and peripherals as may be needed.
- Develop and maintain standard operating procedures and best practices for all aspects of IT infrastructure, including but not limited to acceptable use, architecture, security, disaster recovery and provisioning, system and software guides and manuals, etc.
- Ensure IT systems compliance with relevant finance and regulatory requirements and support finance and/or regulatory teams during audits, as needed
- Management IT contractors and consultants, as needed

- Assist in the analysis of business requirements and evaluation of hardware, software and network capabilities and compatibility to determine optimum IT solutions and configurations;
- Negotiate and administer supplier contracts and service agreements for North America ensuring prompt attention, cost efficiency and within budgetary guidelines.

- Research and propose solutions that fit within the framework of company objectives.
